Financial Assistance School Year 2016-17

Holy Cross of San Antonio offers financial assistance to students whose families demonstrate significant financial need. Based on available funds and the number of applicants each year, Holy Cross makes every effort to provide assistance to those families who need help. Not every family that applies for financial assistance receives aid.

Families are required to reapply for financial assistance each year. Every attempt is made to provide ongoing assistance to returning students that demonstrate continued need.

Process for application:

1. Students must register and be accepted by Holy Cross of San Antonio prior to applying for financial assistance.
2. **Families must apply to Hope for the Future first.** Hope for the Future supports 42 schools in the Archdiocese of San Antonio through tuition assistance. Hope for the Future accepts applications for tuition assistance in February and mails out notifications in May and June. Please go to <http://www.hopeforfuture.org/assistance.html> to apply.
3. After applying for Hope for the Future you may apply for financial assistance from Holy Cross. **Holy Cross will not process an application for financial assistance without acknowledgment from Hope for the Future for SY 2016-17.**

If the applicant is a returning Holy Cross student(s), the family **must have a zero balance by May 10, 2016.**

Financial assistance decisions are made separately from the admissions process and have no impact on a student's eligibility for admission. All families applying for financial assistance must submit their 2015 tax returns with W-2s and all supporting schedules and documents. All financial information is held in the strictest confidence.

The deadline for submitting completed financial assistance applications to the Holy Cross Business Office is May 27, 2015.

All families that apply for financial assistance from Holy Cross will receive a single letter regarding the status of the application whether financial assistance was granted or not by June 30, 2016.

If financial assistance is awarded for SY 2016-17, some volunteer work is required.
